### INSTRUCTIONS FOR "PRE-FILING" RENEWAL BROADCAST ANNOUNCEMENTS AND CERTIFICATION OF COMPLIANCE

## 1. Pre-filing Announcement Instructions

The attached "pre-filing" renewal announcement must be broadcast by the station *once* per day on each of the following days (for a total of *four* announcements):

April 1, 2020 April 16, 2020 May 1, 2020 May 16, 2020

Two of the announcements must be broadcast *either* between 7:00 a.m. and 9:00 a.m. *or* between 4:00 p.m. and 6:00 p.m. The other two announcements may be aired at any time during the broadcast day.

## 2. Certification of Compliance

Within seven days after the conclusion of the cycle of broadcasts of pre-filing announcements (that is, **by May 23, 2020**), complete the attached statement certifying the dates and times of broadcast of the FCC's pre-filing announcements for the station (*and attach the text of the announcements*) and upload the statement and attachment to the station's online public inspection file (in an abundance of caution, we suggest uploading to these two online public file locations: (1) Local Public Notice Announcements, *and* (2) Applications and Related Materials/Additional Documents/Renewal Related Documents).
